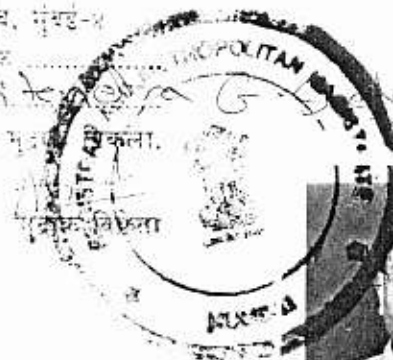

11) That, neither myself nor the individuals mentioned as trustees above claim , intend or seek any kind of monetary consideration or monetary gain for our individual purpose and as such the said Green Mumbai Lions Educational Trust is purely a non- proprietary trust engaged in the academic field, propounding and professing ' Education' in letter and spirit.

I am fully aware that making a false affidavit constitutes a criminal offence.




